Chairman's Report

On behalf of the Board of Directors it is a pleasure to present our annual report which provides details on our activities over the last financial year.

Clarence Village started in 1970, is a registered charity and is 100% community owned. Any surplus funds that are generated are used to further our mission which is to build a community that cares for the aged by providing a home, connection and care. Our vision is a Clarence Valley where seniors live in safety with dignity.

We remain focused on our mission and vision by currently providing 97 independent living units, 45 supported living units and 74 residential aged care beds in Grafton. Our well trained and dedicated staff who number just over 100 provide quality care with support and community connections to nearly 250 residents.

Clarence Village vacancy rates remain very low across our range of accommodation options which is a testament to the great work that we do in the community. It is also very concerning that there is a huge need for affordable housing in our community and many other communities but very little is being done by any level of government to address this most basic need.

We continue to plan for the construction of 32 Independent Living Units at 95 Armidale St in South Grafton. This has taken longer than hoped for due to some issues beyond our control. We are hoping to obtain financial assistance from the State Government for this project. It is our view that there is a urgent need for affordable housing options in South Grafton.


We all look forward to continuing to do good works in our community.

Unfortunately, the inequitable sewer connection charges levied on Clarence Village by Clarence Valley Council threatens these goals.

However as the petition of over 800 signatures supporting our cause demonstrated, the community is on our side and I'm confident those voices will be heeded, either by this Council or the next

Over the course of the year we've continued to work away at the funding that can secure our community its much-needed housing for seniors. This has never been and will never be easy, but it's certainly necessary and so we must succeed.

Activities back with a vengeance

Over the past 12 months the Clarence Village's social calendar has been brimming with events and activities for residents to immersive themselves in and reignite that community spirit that was hampered through lockdowns and isolation directives.

There has been so much socialising and fundraising activities going on it's hard to keep up but here's a rundown of some of the blockbuster happenings over the past year.

Dougherty Villa enjoyed:

Besides the regular raffles for key events like Easter and Christmas, grass roots fundraising reached a new heights this year thanks to the Village's 100 Club which moved to 10-week syndicate, raising \$2000 so far for the Grafton Community Bus. And there's more where that came from thanks to its ongoing popularity and the fervorous support by residents.

A special mention should also go to the Grafton Community Bus and Grafton Playgroup volunteers, whose sausage sizzles raised \$2000 to share between the organisations.



Another first for the Clarence Village community involvement with its sponsorships of Junior Jacaranda candidate Millie Lloyd. Many successful fundraising events for Millie were embraced by residents. At the time of this report, festival announcements were yet to be made but Millie represented the Clarence Village with aplomb.

- Libby Shearer about Advanced Care Directives, what they are and what they mean


All were well attended and some sessions were open to the broader community.

With growth in net assets to \$20.3 million over this financial year, Clarence Village is in a sound and stable financial position.
